



The tenderers are hereby requested to submit their rates on 28/11/16 at CMOH Office, Murshidabad within 1PM and the same will be opened on 28/11/16 at 2 PM positively.

1. Rear body inside lower side wood platform to be replaced by new one.
2. Rear body right side and left side m. s. box angle to be fixed by the riveting and welding with existing support.
3. Rear side complete repair by M.S. Sheet (dala side) with existing gauge.
4. Rear roof complete replaced with existing gauge plate.
5. Rear lower iron beam channel to be changed by new beams.
6. Rear complete door to be repaired with denting and welding jobs.
7. Rear body Complete damaged portion to be repaired with supply of new existing gauge plate and with welding etc jobs.
8. Front cabin inside damaged portion to be repaired properly.
9. All spring leaves sets to be checked and recombined with replacement of shackle pin, bushes, pins, hanger etc.
10. All doors rubber, locks, glass to be repaired ,replaced if necessary..
11. Front safety glass to be replaced by new supply with rubber and to be fitted properly.
12. Complete electric wiring to be checked and replaced with new supply.
13. Both side looking glass to be replaced.

15. Engine oil filters and diesel filters to be replaced
16. Complete body to be painted with good quality of paint , inside, outside& cabin portion, under chassis portion, rear side after scraping the whole body .
17. Rewrite the all symbols and no etc.
18. Battery line to be checked properly.
19. Inside cabin portion and rear cab side portion polyvinyl sheet to be fitted properly.
20. Attained the G.I. Inspection jobs to be done which are to be needed as vehicle was lying in off-road condition for long time.
