TERMS & CONDITIONS FOR SUPPLY OF MATERIALS

1. **Intending tenderer who will quote rate for other than OTIS should be submitted Electric Traction Elevator specification with the tender documents.**
2. If the offered rate of the Tenderer accepted by this Parishad, Delivery of Lift will not be accepted on Saturdays, Sundays and Holidays.
3. Rate should be quoted inclusive of all taxes, charges etc., loading carriage, unloading, annual maintenance and installation at DPTRC, Panchanantala, Berhampore, Murshidabad.
4. If the offered rate of the Tenderer is accepted by this Parishad, the Supplier/ Tenderer will have to ensure against manufacturing defects for a period of 6(Six) months from the date of final acceptance. If any defect, whatsoever develops during this period the same will have to be replaced by the Supplier/ Tenderer by a new one at their own cost.
5. The Deposited amount of the unsuccessful quotationers will be released in due time.
6. **If Earnest Money** not cover the 2% of the awarded cost, **additional Earnest Money** should be deposited in the IDBI Bank **Account No. 0257104000108225**, IFS CODE – **IBKL0000257** in favour of MZP Tender A/C, through RTGS/NEFT/CBS System to cover the 2% of the awarded cost failing which

your quotation will be treated as cancelled and the earnest money deposited by you will stand forfeited to this Parishad.

7. Security deposit @ Rs. 10% of the bill amount will be kept deducted from the bill. Earnest money as deposited by the Supplier/ Tenderer will be kept as Security deposit and balance amount will be kept from the bill at the time of payment.
8. Security money will be returned after six months in case of no defect is detected in the supplying materials in the mean time.
9. In case of unwillingness of the successful quotationer(s) to accept the work order at his/their quotation rate, the amount deposited as Earnest money will be forfeited in favour of Zilla Parishad fund.
10. If the offered rate of the Tenderer is accepted by this Parishad, supply & installation should be made within 30(thirty) days from the date of issuance of the order of this Office.
