Cost of Bidding Documents and Security Deposit should be deposited in IDBI Bank Account No. 0257104000108225, IFS CODE – IBKL0000257 in favour of MZP Tender A/C, through RTGS/NEFT/CBS System only. The NIA No. and/or UTR number should be clearly mentioned on the deposit challan. Payment made otherwise will be rejected.

Auction Elapse time is maximum 5[five] minutes and Auction Bid auto extensions is also 5[five] minutes. The e-auction shall be an ascending forward online electronic auction. Minimum incremental value is Rs. 1000/- and maximum is 50% of base rate.

The Eligibility Criteria are given below:-

1. Income Tax return should be uploaded for the 3 financial years with the auction documents.
2. PAN Card, Voter Card [for individual only], P. Tax Challan for the financial year 2016-2017 and trade license should be uploaded.

3. The partnership firm shall furnish the partnership deed in the case of Registered Company from Govt. of WB, Kolkata, West Bengal, Company shall furnish the Article of Association and Memorandum.
4. Registered Unemployed Engineers' Co-operative Societies/ Unemployed Labour Co.- Op. Societies are required to furnish valid Bye Law, Current Audit Report, Valid Clearance Certificate from A.R.C.S. for the last year along with other relevant supporting papers.
5. No CONDITIONAL/ INCOMPLETE auction will be accepted under any circumstances.
6. Before issuance of the Lease Order, the Auction inviting authority may verify the documents of the highest bidder if found necessary. After verification, if it is found that such documents submitted by the highest bidder is either manufacture or false in that case, Lease Order will not be issued in favour of the highest bidder under any circumstances and auction will be treated as cancelled, as well as the security money should be forfeited in favour of the Murshidabad Zilla Parishad.
7. Receipt copy of deposit (Cost of Tender Paper & Earnest money) Challan should be submitted/uploaded with the tender documents.
8. All the documents in proof of their eligibility IN ORIGINAL need to be produced as and when asked and Required.
9. Information regarding any litigation or arbitration during the last five years in which the Bidder is involved, the parties concerned the disputed amount, and the matter.
10. Bank Solvency Certificate on 100% of Base Rate should also be uploaded.
11. A Grant Order/ Letter of Intent (LoI) shall be issued by the Murshidabad Zilla Parishad to the Successful Bidder upon payment of 100% of the bid amount after adjusting with Security deposit within 7(Seven) days after being so declared. Failing which the Security money will be forfeited.

12. Rate may be imposed as per table below. Without prior approval of Murshidabad Zilla Parishad, rate will not be enhanced at any circumstances.
