Sealed Quotation is being invited from bonafied Commercial Car Owners in their own letter head pad for Nezarat Section, Murshidabad on monthly rental basis for 09 (Nine) months.

The Quotation is invited under the following terms & conditions.

Terms & Conditions:

1. Rate shall be inclusive of all i.e. insurance claim, tax levied on the vehicle, charges for rendering certificate of fitness etc.
2. The vehicle must possess commercial licence.
3. The photocopy of valid papers shall be required to be submitted along with the Quotation.
4. The fuel shall be issued to the vehicle by the office on day to day basis. The consumption of fuel shall be in accordance with the Govt. Orders in respect. Any excess consumption of fuel shall be ordinarily be borne by the contractor / vehicle owner & shall be added lowest rate.
5. Income Tax & other incidental charges shall be levied from the bill as per I.T Act, 1961 & other relevant Acts & Rules.
6. The authority reserves the right to accept / reject any or all Quotations & cancel the Quotation Notice without assigning any reason thereof.

7. Though, the Quotation is being called for hiring for Nine (09) month, the authority may release the vehicle before expiry of that period on his own discretion, if situation demands, by giving 30 days notice period imitating the release.


