Notice Inviting e-Tender No. 53 of 2017-18

Sealed Tender is hereby invited in prescribed proforma from the manufacturers/authorized dealers or Bonafied Suppliers for Supply of Life jackets, Life Buoya, Life Buoya with light & life line, Air filled / foam floating rubber tubes with string, Installation of Public address system, Supply of Fire Extinguisher, 9 litre mechanical foam and supply of Fire Bucket with stamp in the 20 nos. of different Ghats. Approx amt. involve Rs. 26.00 lakhs.

The Quotations duly filled in all respect deposit challan should be submitted **online** to the Addl. Necessary Earnest Money and Cost of Tender Paper will be deposited by the bidder electronically: online – through his net banking enabled bank account, maintained at any bank or: offline – through any bank by generating NEFT/ RTGS challan from the e-tendering portal [https://etender.wb.nic.]. Intending Bidder will get the Beneficiary details from e-tender portal with the help of Digital Signature Certificate and may transfer the EMD from their respective Bank as per the Beneficiary Name & Account No., Amount, Beneficiary Bank name (ICICI Bank) & IFSC Code and e-Proc Ref No. Intending bidder who wants to transfer EMD through NEFT/RTGS must read the instruction of the Challan generated from E-Procurement site. Bidders are also advised to submit EMD of their bid, at least 3 working days before the bid submission closing date as it requires time for processing of Payment of EMD. Bidders eligible for exemption of EMD as per Govt. rule may avail the same and necessary documents regarding the exemption of EMD must be uploaded in the EMD folder..

If the offered rate of the Tenderer is accepted by this Parishad, the Supplier/ Tenderer will have to ensure against manufacturing defects for a period of 1(one) month from the date of final acceptance. If any defect, whatsoever develops during this period the same will have to be replaced by the Supplier/ Tenderer by a new one at their own cost.
4. The Deposited amount of the unsuccessful quotationers will be released in due time.
5. **If Earnest Money** not cover the 2% of the awarded cost, **additional Earnest Money** should be deposited in the IDBI Bank **Account No. 0257104000108225**, IFS CODE – **IBKL0000257** in favour of MZP Tender A/C, through RTGS/NEFT/CBS System to cover the 2% of the awarded cost failing which your quotation will be treated as cancelled and the earnest money deposited by you will stand forfeited to this Parishad.
