- 3. The successful tenderer will have to submit PowerPoint presentation of the communication plan on demand. Quality of the PowerPoint presentation along with quoted rate may be considered during selection of successful tenderer.
- 4. The tender paper is available from the District IT Section Office of the District Magistrate, Murshidabad free of cost. Tender paper is available upto 12 Noon on 06.03.2018.
- 5. The rate to be quoted by the tenderers must be single one and covering the full volume of the material mentioned in para-II and must be less than Rs. 500000/- (Rupees Five Lakh only) inclusive of all applicable taxes and duties.
- 6. Cost of earnest money Rs. 20,000/-(Rupees Twenty thousand only) should be deposited in the form of bank draft, made in favour of District Magistrate, Murshidabad.
- 7. The intending tenderers should submit tenders within specified time along with a photocopy of PAN card, latest IT return submitted by them, GST registration certificate containing GSTIN.

- 8. Sealed tenders will have to be dropped in the tender box kept at the office chamber of Officer-in-Charge IT Murshidabad from 11 A.M. to 4 P.M. on all working days except Saturdays, Sundays and other holidays. On 06.03.2018 tenders can be dropped only between 11 A.M. and 2 P.M.
