1. District Magistrate Murshidabad invites tender for Information Education and Communication (I.E.C) materials in connection with 'Egiye Murshidabad' Mobile App. The required specification and volumes of the materials are given below:
 - a. Flex for hoarding – 10 Ft X 20 Ft in size – 32 pieces.
 - b. Banners – 4Ft X 8 Ft in size – 150 pieces.
 - c. Paper insert - 20000 pieces.
 - d. Handouts – 20000 pieces.
 - e. Posters – 7500 pieces.
2. The content and the design for the above IEC materials will be provided by the Office of The District Magistrate, Murshidabad.
3. The material has to be supplied to the office of the District Magistrate within 3 days from the issuance of the Work order/Supply order.
4. The tender paper is available from the District IT Section Office of the District Magistrate, Murshidabad free of cost. Tender paper is available upto 12 Noon on 07.03.2018.
5. The rate to be quoted by the tenderers must be covering the full volume of the material mentioned in para-I and must be less than Rs. 500000/- (Rupees Five Lakh only) inclusive of all applicable taxes and duties.
6. Cost of earnest money Rs. 20,000/- (Rupees Twenty thousand only) should be deposited in the form of bank draft, made in favour of District Magistrate, Murshidabad.
7. The intending tenderers should submit tenders within specified time along with a photocopy of PAN card, latest IT return submitted by them, GST registration certificate containing GSTIN.
8. Sealed tenders will have to be dropped in the tender box kept at the office chamber of Officer-in-Charge IT Murshidabad from 11 A.M. to 4 P.M. on all working days except Saturdays, Sundays and other holidays. On 07.03.2018 tenders can be dropped only between 11 A.M. and 2 P.M.

9. The last date and time of submission of tender is 07.03.2018 upto 2 P.M. at the chamber of Officer-in-Charge IT, Murshidabad.
10. The date and time of opening of tender is 07.03.2018 at 3 P.M. at the chamber of Officer-in-Charge IT, Murshidabad. The intending tenderers or their authorised representatives may remain present at the time of opening of tender.
11. The undersigned is not bound to accept the lowest rate.
12. The undersigned reserves the right to accept or reject any tender or to distribute the work amongst the participating tenderers without assigning any reason whatsoever.
