- Tender which should always to sealed in a covers with the name of work and NIT No. and SI No. of the work written on the envelop will be received by the Office as per NIT and tender will be opened on the day and the hours by the Tender Committee of Murshidabad Zilla Parishad.
- Eligibility criteria for all Contractors:-**
  - The credential should be submitted at least **40%** of the amount put to Tender.
  - The Credential should be in the name & style of the intending tenderer only, and not in the name and / or style of any of the Partner(s).
  - Income Tax return should be submitted for the AY-2016-17 & AY-2017-18 with the technical bid.
  - Professional Tax receipt Challan for the year 2017-18, Trade License & Pan Card should be submitted.
  - Receipt copy of deposit (Earnest money & Cost of Tender paper) challans should be submitted with the tender documents [technical].
  - Rate should be quoted on printed letter Head Pad of the concerned agency in separate envelop.**
  - Bidders eligible for exemption of EMD as per Govt. rule may avail the same and necessary documents regarding the exemption of EMD must be submitted with tender documents.
- Only original papers in support of the copies submitted may be produced as & when asked for.
- Acceptance of tender will rest with authority as shown in the list enclosed, who does not bind himself to accept the lowest or any tender and reserves to himself the right to reject any or all of the tenders received, without assigning any reason. In this context the discretion of the Tender Committee will be final and binding upon the tenderer.
- The contractor whose tender is accepted will be required to furnish security deposit for the due fulfillment of his contract amounting 10% (ten percent) of the total value of work actually done. The earnest money shall be converted as a part of the security money and the balance shall be realized by deduction from each

progressive bill so that the total deduction together with earnest money already taken constitutes 10% of the total value of the work actually done.

7. The rates quoted by the contractors should include W.B. GST and other taxes liable under local rates.
8. This notice additional terms and condition if any will form part of contract. They must be submitted along with tender form duly signed by the contractor, failing which the tender is liable to be cancelled.
9. The power of attorney which may be characterized as agency agreement will not be accepted without specific order of the government.
10. The tenderers are requested to be present at the time when the tenders will be opened and read out by the Addl. Executive Officer, Murshidabad Zilla Parishad and to put initial in the register as a token of witness.
11. Payment of bill will be made as per availability of fund. No claim for delay of payment due to non availability of fund will be entertained. At the time of payment of each bill IT & GST will be deducted in terms of section 194( i ) of the Income Tax Act, 1961 and in terms of Notification of GST Act of Govt. of West Bengal.
