3. Sketch map of storing point mentioning the capacity in metric ton (Godown) along with copy of deed (in case of owned properties) or agreement of rent / lease (if not owned) should be submitted with the application.

After verification of credential and solvency of such applicants, they will submit an affidavit ( copy of affidavit is enclosed) on a non-judicial stamp paper of Rs. 10.00 along with a demand draft drawn in favour of the District Magistrate Murshidabad, MDM Account, payable at Berhampore (W.B) amounting to Rs.5000.00 (Rupees five thousand only) as application fees (non- refundable).
