Basic Qualification Criteria :

(A)Credential : The applicant, in the same name and style, as prime contractor should have successfully completed at least one contract of same type of work at least **one-third** value of the proposed contract within the last 5 years. Credential of same name and style for bituminous road means, Original bituminous work or repair and maintenance of bituminous road work.

For concrete road work/Drain Work credential of same and style will include original C.C road construction, concrete guard wall construction, Bridge and building construction with concrete work as one of the important item of work.

(B) Turnover : The bidder should have achieved in any one year during last five financial years in the same name and style (excluding current year) a minimum financial turnover as certified by chartered accountant and at least 50% of which is from civil engineering construction works equivalent to amount given below.

(i) 60% of amount put to bid in case of the amount put to bid is up to Rs. 50 lakh and

(ii) 75% of Amount put to bid in case of the amount put to bid above Rs. 50 lakhs but less than Rs.200

Lakh for which bid has been invited. The Turn Over will be indexed at the rate of 8% per year.

NOTE: The annual turnover of the bidders will be evaluated based on the uploaded payment Certificates only. The financial turnover as certified by the chartered accountant is only indicative. Out of the total turnover 50% should be from Civil Engineering works.

(C) Bid Capacity: Bidders who meet the minimum qualification criteria will be qualified only if their available bid capacity for construction work is equal to or more than the total bid value. The available bid capacity will be calculated as under:

Assessed Available Bid capacity = (A*N*M - B) Where

A = Maximum value of civil engineering works executed in any one year during the last five years taking into account the completed as well as works in progress, N = Number of year prescribed for completion of the work for which bids are invited ,for period upto 6 months to be taken as ½ and for more than 6 months as 1, M = 3, B = Value, at the current price level, of existing commitments and on-going works to be completed during the period of completion of the works for which bids are invited.

N.B. 1. The statements showing the value of existing commitments and on-going works as well as the stipulated period of completion remaining for each of the works listed should be countersigned by the Engineer in charge, not below the rank of an Executive Engineer or equivalent.

(D) Documents & Certificates: Self Attested copies of I.T, P.T, C.C, GST/VAT, Registration Certificate must be uploaded by all bidders .For registered Engineers Co- Operative Society & Registered labour Co-Operative Society including submission of Bye-Laws, their area of operation, valid audit report for the last three (3) years, valid ARCS certificates and other papers & submit the same with full address of their authorized person to sign on tender documents along with Technical Bid papers.

Disqualification Criteria: Even though the bidders meet the above qualifying criteria, they are subject to be disqualified if they have:

(i) Made misleading or false representations in the forms, statements, affidavits and attachments submitted in proof of the qualification requirements; and / or record of submission of any false / fake document(s).

(ii) Record of poor performance such as abandoning the works, not properly completing the contract, inordinate delays in completion, litigation history, or financial failures etc.

(iii) Participated in the previous bidding for the same work and had quoted unreasonably high or low bid prices and could not furnish rational justification for it to the Employer.

Bids from joint ventures - Not allowed

Rejection Criteria: i) During scrutiny of Technical Bid / Tender documents, or any time prior to opening of financial bid, if it is found that any information in any supportive document is false or incorrect/misleading to that extent, that it frustrates the very basis of submission of that document, then the tender of the concerned bidder will be rejected, without assigning any reason whatsoever, ii) If it is found that there is continuous poor performance and inordinate delay in execution of the works already awarded to them. The Executive Engineer (PIU- Head), WBSRDA, Murshidabad, Jangipur Division on behalf of the Chief Engineer, P&RD will have sole discretion to decide the eligibility of the Contractors on the basis of his submitted documents and evaluation thereof and reserve the right to refuse any explanation to Contractor or to refuse issuance of tender to any applicant without assigning any reason thereof and his decision in this respect will be final.

Forfeiture of Earnest Money:

Apart from Disqualification and Rejection of tender, the **Earnest Money** deposited by the bidder will be **forfeited** if they submit **false/fake/forged** documents in respect of Credential and Turnover.

WBSRDA, Jangipur Division does not take any responsibility for the delay caused due to non availability of internet connection or server problem etc. for online bids. bids shall summarily be rejected. Special Terms & Condition:

1. Challan of Bitumen Procurement / Cationic Emulsion must be produced for all Bituminous Construction work, prior to execution of the item.
2. Message regarding “Technically Qualified/Disqualified” will be communicated to the Bidders. Financial Bid will be opened within a short period after such communication. In case of there be any objection regarding Technical Scrutiny, objection should be lodged to the under signed within 72 hours from time of uploading of the Technical Bid and subsequently communication to Bidder Beyond that time schedule no objection will be entertained.
3. BIDDER INFORMATION FORM (BIF) duly filled should be uploaded, if not tender will be treated as cancelled.
4. BAR Chart duly filled should be uploaded, if not, tender will be treated as cancelled.
5. All require documents should be uploading in Bidder File.

The pre-qualification documents (Technical Bid) alone will be opened on **24.09.2019 Time: - 11.00 Hours** and the date & time of opening financial bid document of the technically qualified bidders will be intimated in due time after technical evaluation technically qualified bidders will be declared. The other Financial Bid documents (Unqualified technical Bidders) will remain unopened. No separate intimation will be given for this, unless the above date is changed. In case of change of date, due intimation will be given in Notice Board. No individual intimation will be given. Name of the qualified bidders will be displayed in the office notice board.

The Executive Engineer, WBSRDA, Murshidabad Division reserves the right to reject or cancel any or all pre-qualification documents and bid document without assigning any reason whatsoever.

1. Achieved in any one year during last five years in the same name and style (excluding current year) a minimum financial turnover at least 100% (similar nature of works) of the Estimated Amount put to tender. Tax Audit report in Last 5 years (F.Y-13-14, 14-15, 15-16, 16-17& 17-18) (respective payment Certificate to be attached Govt. Department. Annual Turnover in contractual business should be authenticated by a Chartered Accountant.
2. Income Tax return should be submitted/uploaded for the last 03 (Three) (15-16, 16-17& 17-18 F.Y) financial years with the technical bid.
3. Professional Tax Receipt Challan for the year 2018-2019, Pan Card, Trade Licence, Clearance Certificate up to date, to be submitted/uploaded.
4. Tax invoice(S) needs to be issued by the Supplier for raising claim under the contract, showing separately the tax charged in accordance with the provisions of GST Act' 2017.
5. A prospective bidder shall be allowed to participate in the work either in the capacity of individual or as a partner of a firm.
6. The partnership firm shall upload the registered partnership deed and the company shall furnish the Article of Association and Memorandum.
7. Copies of original documents defining the constitution or legal status, place of registration, and principal place of business; written power of attorney of the signatory of the Bid to commit the Bidder.
8. All the documents in proof of their eligibility IN ORIGINAL need to be produced as and when asked and required.
9. Information regarding any litigation or arbitration during the last five years in which the Bidder is involved, the parties concerned the disputed amount, and the matter.
10. Prospective bidders shall have to execute the work in such a manner, so that appropriate service level of the road under improvement is to be maintained during progress of work till completion and a period of 1 (one) year from the date of successful completion of the work to the entire satisfaction of the Engineer-in- Charge. If any defect/ Damage is found during the period as mentioned above the contractor shall make the same good at his own expense to the specification at per with instant project work. Security deposit will be refunded after 1 (one) year as to be counted from the date of issuance of completion certificate by the E.I.C. The security may be extended up to 20% as per discretion of E.I.C.
11. The Bidder should submit affidavit on Rs. 10/- non-judicial stamp paper stating the information furnished with the tender document is correct in all respect.
12. Time allowed for completion of work is 3 (three) months from the date of issue of work order. The intending bidders are requested to inspect the work site before quoting their rates. The payment will be made as per availability of fund under post five years maintenance works.
13. Bidder/Agency must submit the prescribed earnest money from their own Account No, otherwise their bid will be treated ad cancelled.
14. After issue of work order, if the agency showing unwillingness to execute the work, the work order will automatically be cancelled and Earnest money will also be forfeited.

15. To qualify for a work of contracts made up of this and other contracts for which bids are invited in the Notice Inviting Tender, the bidder must demonstrate having experience and resources [Bank Solvency Certificate not less than 50% of Tender amount, Bank solvency certificate not beyond 06 (Six) months, Applicable only where the Tender amount is more than Rs.50.00 lakhs] sufficient to meet the aggregate of the qualifying criteria for the individual contracts.

16. IMPORTANT INTRUCTION TO BIDDERS

- i) Completion Certificates for fully (100%) completed works during the current year and last five financial years will only be accepted. Certificates issued for partly completed work will not be considered.
- ii) The self attested copy of payment Certificate must be uploaded online for evaluation of Turn over & amount of Civil Engineering work done.
- iii) A bidder shall apply for not more than one work with a single valid credential certificate.
- iv) No bidder is allowed to sub-let/subcontract/sublease the works in any form part or full stated in the above NIT as per decision of the competent authority.

17. All require documents should be uploading in Bidder File.

18. Even though the bidders meet the above qualifying criteria, they are subject to be disqualified and legal action may be taken if they have:

- I. Made misleading or false representations in the forms, statements, affidavits and attachments submitted in proc of the qualification requirements; and / or record of submission of any false / fake document(s).
- II. Record of poor performance such as abandoning the works, not properly completing the contract, inordina delays in completion, litigation history, or financial failures etc.
- III. Participated in the previous bidding for the same work and had quoted unreasonably high or low bid prices & could not furnish rational justification for it to the Employer.

All duties, taxes, royalties, cess [including 1% cess under W.B. Building and other Construction workers (Regulation of Employments& condition of service) Act,1996], toll, taxes, and other levies payable by the Contractor under the Contract to the State/Central Govt. For anyother cause, shall be included in the rates, prices and total Bid price submitted by the bidder. 1% cess under W.B. Building and other Construction workers (Regulation of Employments & condition of service) Welfare Cess Act, 1996 will be deducted from the each running account bill.
