WBSRDA, Murshidabad Division does not take any responsibility for the delay caused due to non-availability of internet connection or traffic jam etc. for online bids. Scan copy of the earnest money (as mentioned against each work) and non-refundable of cost of tender paper/documents as mentioned drawn in favour of "Executive Engineer, WBSRDA, Murshidabad Division" payable at SBI-ADB, Berhampore Br, a/c no:- 11176118727, IFSC Code: SBIN0003914 by RTGS/NEFT also be uploaded in the technical bid folder.

The pre-qualification documents (Technical Bid) alone will be opened on 19/06/2020, Time-10:00 Hours and the date & time of opening financial bid document of the technically qualified bidders will be intimated in due time after technical evaluation technically qualified bidders will be declared. The other Financial Bid documents (Unqualified technical Bidders) will remain unopened. No separate intimation will be given for this unless the above date is changed. In case of change of date, due intimation will be given in Notice Board. No individual intimation will be given. Name of the qualified bidders will be displayed in the office notice board.

The Executive Engineer, WBSRDA, Murshidabad Division reserves the right to reject or cancel any or all pre-qualification documents and bid document without assigning any reason whatsoever.

The eligibility criteria are given below: -

1. Achieved in any one year during last Three years in the same name and style (excluding current year) a minimum financial turnover at least 100% (similar nature of works i.e Bitumen Works) of the Estimated Amount put to tender. Tax Audit report in Last 3 years (F.Y- 16-17, 17-18& 18-19) (respective payment Certificate to be attached Govt. Department. Annual Turnover in contractual business should be authenticated by a Chartered Accountant.
2. The bidder must have successfully completed PMGSY road or Post Five Year Maintenance Work of PMGSY road under WBSRDA within last Five (05) years or having 60% credential in similar nature of work in any other Government Department in last 3 (three) years and have to submit documentary evidence of the same i.e. Payment Certificate or Completion certificate and Work Order. The issuing signatory of the same shall not be below the rank of Executive Engineer or Executive Officer.
3. The similar type of credential (Issued From only Govt. or Govt. recognized Institute) should be submitted/uploaded at least 60% of the amount put to Tender supported by the Work Order, Final Payment Certificate or Completion Certificate [within last five (5) years for PMGSY works & within the last 3 years for


- Other Department] in the same nature/style of single work & completed the work successfully (similar nature of works i.e Bitumen Works).
4. The Credential should be in the name & style of the intending tenderer only, and not in the name and / or style of any of the Partner(s). Please note that, Final Payment Certificate or Completion Certificate along with Work Order will only be entertained as CREDENTIAL (similar nature of works i.e Bitumen Works).
 5. Income Tax return should be submitted/uploaded for the last 03 (Three) (F.Y- 16-17, 17-18 & 18-19) financial years with the technical bid.
 6. Professional Tax receipt Challan for the year 2019-20, Pan Card, Trade Licence, Clearance Certificate up to date, to be submitted/uploaded.
 7. Tax invoice(S) needs to be issued by the Supplier for raising claim under the contract, showing separately the tax charged in accordance with the provisions of GST Act' 2017.
 8. Bank solvency certificate 50% of the Estimated Amount should be issued any Nationalized Bank and Such Certificate must contain the name of the scheme.
 9. A prospective bidder shall be allowed to participate in the work either in the capacity of individual or as a partner of a firm.
 10. The partnership firm shall upload the registered partnership deed and the company shall furnish the Article of Association and Memorandum.
 11. Each Bidder shall submit/upload Maximum two nos Bids in each serial of the NIT. A Bidder who submit/upload More Than Two Bids for the same NIT, the bidder's participation to be disqualified. Each agency is eligible to be get maximum two nos. of work against each set of own/lease machinery (Lease Agreement duly registered).
 12. The scope of Sub-Contracting is not allowed strictly by any way.
 13. Intending Labour Co-Operative Societies & Unemployed Engineers' Co-Operative Societies should enclose the documents in proof of their Registration & Validity to participate in this Tender during the period of deposition of the Tender. No exemption will be allowed regarding deposit of Earnest Money.
 14. Receipt copy of deposit (Cost of Tender Paper & Earnest money) Challan should be submitted/uploaded with the tender documents.
 15. Copies of original documents defining the constitution or legal status, place of registration, and principal place of business; written power of attorney of the signatory of the Bid to commit the Bidder.
 16. All the documents in proof of their eligibility IN ORIGINAL need to be produced as and when asked and required.
 17. Information regarding any litigation or arbitration during the last five years in which the Bidder is involved, the parties concerned the disputed amount, and the matter.
 18. To qualify for a work of contracts made up of this and other contracts for which bids are invited in the Notice Inviting Tender, the bidder must demonstrate having experience and resources sufficient to meet the aggregate of the qualifying criteria for the individual contracts.
 19. The scope of Sub-Contracting is not allowed strictly by any way.
 20. Prospective bidders shall have to execute the work in such a manner, so that appropriate service level of the road under improvement is to be maintained during progress of work till completion and a period of 1 (one) year from the date of successful completion of the work to the entire satisfaction of the Engineer-in- Charge. If any defect/ Damage is found during the period as mentioned above the contractor shall make the same good at his own expense to the specification at per with instant project work or Security Deposit amount will be forfeited based on certification issued from the end of Engineer in Charge. **Security deposit will be refunded after 2 (Two) year as to be counted from the date of issuance of completion certificate by the E.I.C. The security may be extended up to 20% as per discretion of E.I.C.**
 21. The Bidder should submit affidavit on Rs. 10/- non-judicial stamp paper stating the information furnished with the tender document is correct in all respect.
 22. Negotiation with L2 bidder is prohibited:-
 23. Bidder/Agency must submit the prescribed earnest money from their own Account No, otherwise their bid will be treated ad cancelled.

24. After issue of work order, if the agency showing unwillingness to execute the work within the period of (fifteen) days, in consequence that the work order will automatically be cancelled and Earnest money will also be forfeited.
25. **BIDDER INFORMATION FORM (BIF) duly filled should be uploaded, if not tender will be treated as cancelled.**
26. All require documents should be uploading in Bidder File.
27. Time allowed for completion of work is 3/4 (three/four) months from the date of issue of work order. The intending bidders are requested to inspect the work site before quoting their rates. **The payment will be made as per availability of fund under post five years maintenance works.**
28. Bidder should be submit From 26 ASⁿ of last 3 (three) years, otherwise their bid will be treated as cancelled.
29. Even though the bidders meet the above qualifying criteria, they are subject to be disqualified and legal action may be taken if they have:
- Made misleading or false representations in the forms, statements, affidavits and attachments submitted in proof of the qualification requirements; and / or record of submission of any false / fake document(s).
 - Record of poor performance such as abandoning the works, not properly completing the contract, inordinate delays in completion, litigation history, or financial failures etc.
 - Participated in the previous bidding for the same work and had quoted unreasonably high or low bid prices and could not furnish rational justification for it to the Employer.
30. Any Black listed agency / bidder would not be able to participate in bidding process.

All duties, taxes, royalties, cess [including 1% cess under W.B. Building and other Construction workers(Regulation of Employments& condition of service)Act,1996],toll, taxes, and other levies payable by the Contractor under the Contract to the State/Central Govt. For any other cause, shall be included in the rates, prices and total Bid price submitted by the bidder. 1% cess under W.B. Building and other Construction workers (Regulation of Employments & condition of service) Welfare Cess Act, 1996 will be deducted from the each running account bill.

WBSRDA MURSHIDABAD DIVISION reserves the right to accept or to reject any or all Tenders or can distribute a part or whole of any work to any or among more than one Tenderer without assigning any reason.




